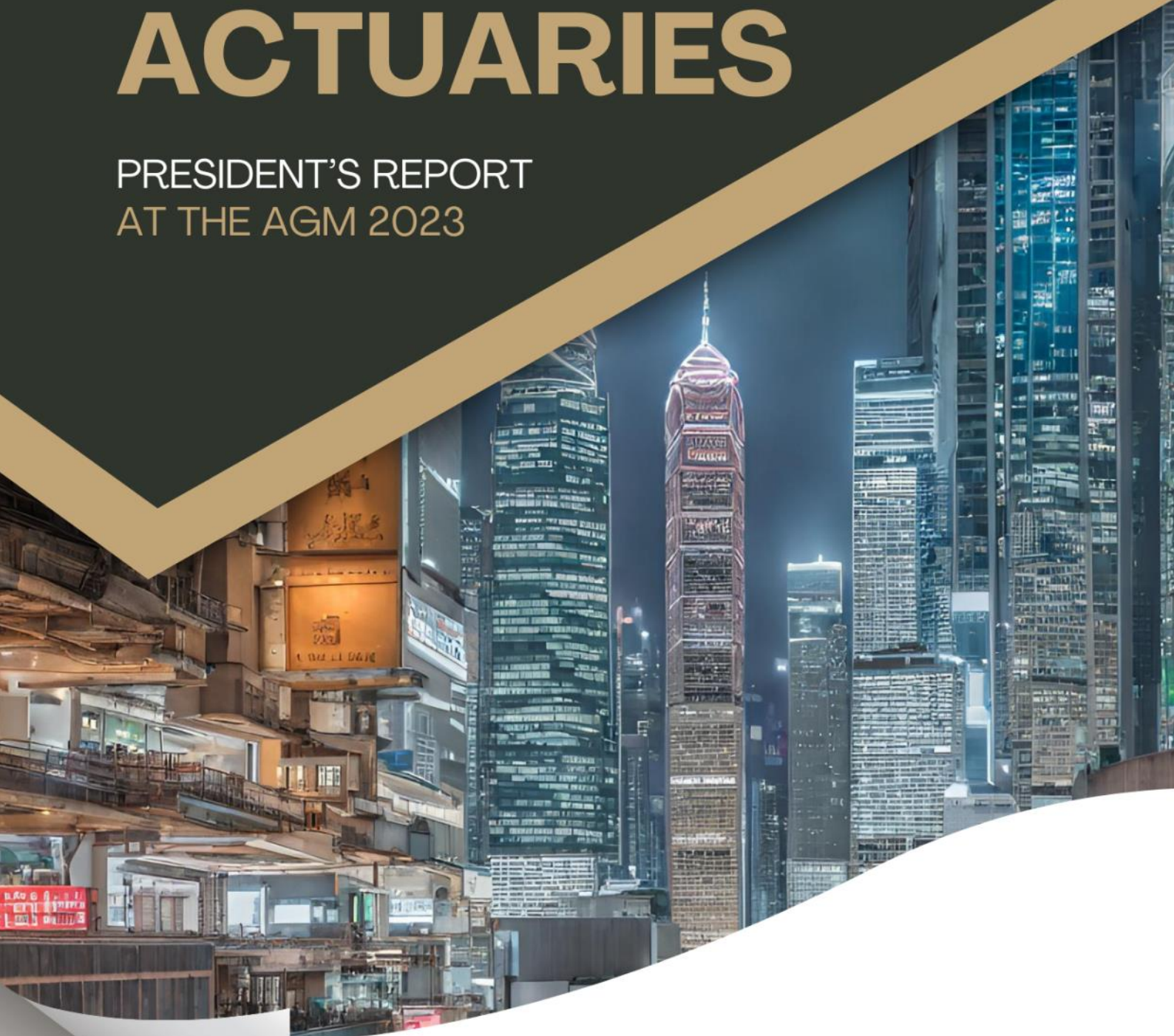

# **2024 ASHK President's Acceptance Speech - Timothy Wong**

Fellow members and supporters of our profession, I would like to thank all of you for giving me the honour to act as President of the Actuarial Society of Hong Kong to serve all of you in 2024. It is a privilege of which I am both grateful and proud.

I would like to first thank Simon Lam, for his leadership and tireless dedication to the ASHK, serving as our President this year, and Alexander Wong for serving as our Immediate Past President. My appreciation also goes to the Council members, Committee volunteers, our Honorary Legal Adviser and Auditor for their support and guidance during my year as Vice President. Lastly, thank Damian and his team for keeping the ASHK office in order.

I would also like to welcome new Council members and look forward to working with all the Council members over the next year.

I intend to keep this short as I am standing in front of everyone's dinner. But please allow me to share with you my vision in 2024, that is going to be an exciting and rewarding year. There are four missions to go:

- 2024 Asian Actuarial Conference (AAC) – It is an Olympic alike event in the actuarial world, that is expected to bring together more than 700 actuaries, insurance professionals and academics from across the world to Hong Kong to discuss the most important issues facing the actuarial and insurance industry in Asia. It is a great opportunity to showcase Hong Kong as Asian actuarial and risk-management hub. The success of AAC will be a symbolic success of our profession. I sincerely ask all of you for your kind support to make our AAC a great success.
- Hong Kong Risk Based Capital (RBC) – Insurance Authority (IA) has announced in last Friday Asian Insurance Forum that Hong Kong RBC is expected to go live in 2024. ASHK have been and will remain deeply engaged with IA on this fundamental change to the industry. We will continue to proactively share our professional voices to IA to serve the public interest. We will also continue to enhance our Professional Standard and Actuarial Guidance Note, strengthen our exam offering and prepare offering exam equivalent course to support the Hong Kong RBC go live.

- IA Participating Fund Management Proposal – IA introduced the PAR Fund Management Proposal to the industry in September this year. The PAR fund business is pivotal in our life insurance market and the current proposal raises different implications with our profession and the insurance industry. ASHK have been and will remain deeply engaged with IA on this critical subject. We will consider setting up Special Project Team on PAR Fund Management and work hand in hand with the HKFI PAR Fund Management Special Project Team.
- Last but not least, the “Statutory Body project” – 2024 is going to be an exciting year as we expect be a Fellow of ASHK as a requirement of Appointed Actuary and Certifying Actuary will be effective next year. But we will not stop here. We will continue our journey to be a Statutory Body until we get there.

**Insurtech Sandbox** – Allows authorized insurers to experiment their innovations and other technology applications with real market data and information in a controlled environment.

**Fast track for applications for authorisations of new digital channel only insurers** – an expedited and streamlined process compared with other insurance license applications.

**Insurtech Facilitation Team** – a team maintained by the regulator to enhance the communication with business involved.

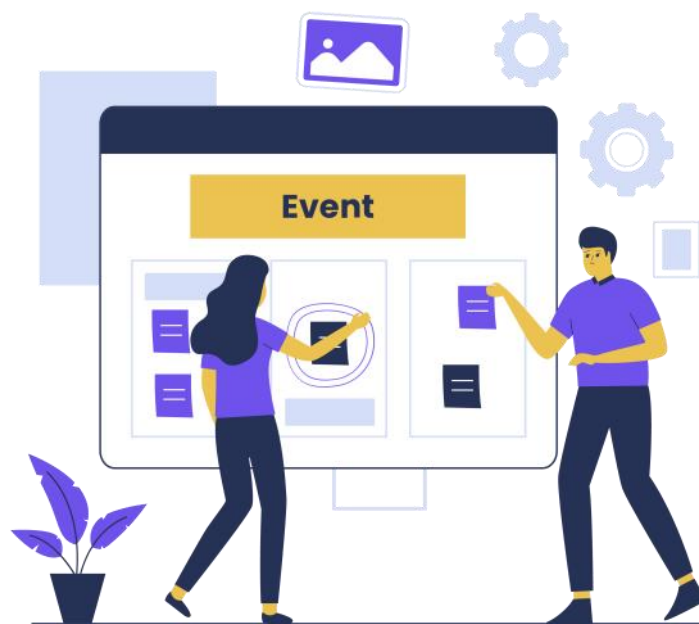

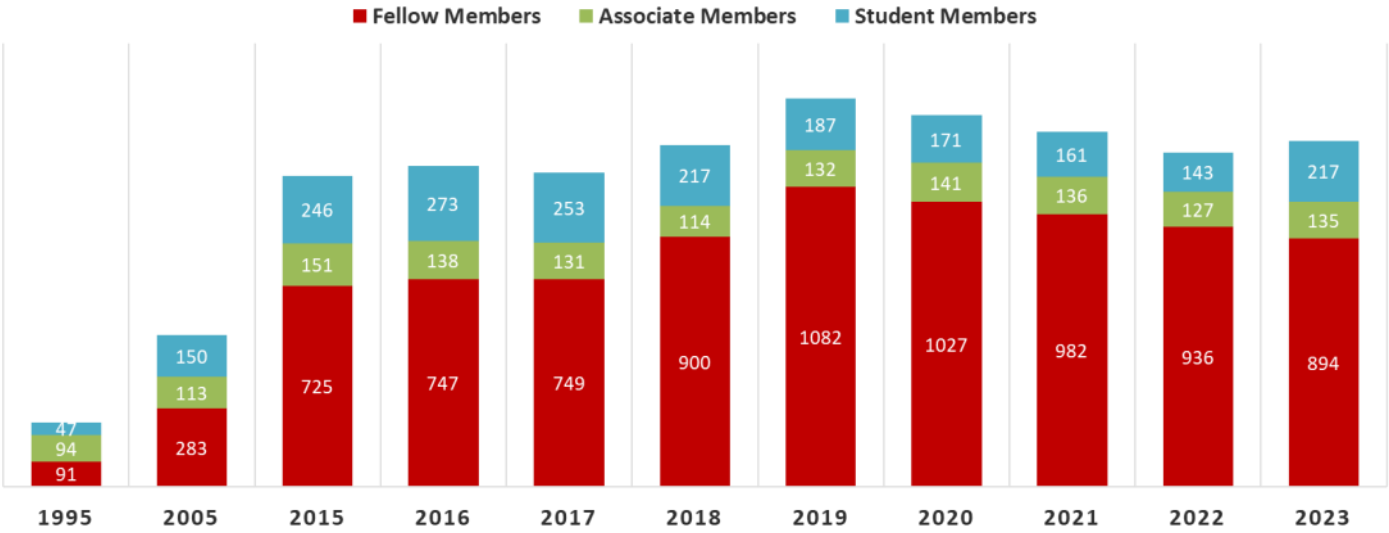
